The purpose of the meeting is to permit parties to present testimony and exhibits relative to Brenda Rodriguez's complaint against Duke Energy Florida, Inc. for improper billing and for such other purposes as the Commission may deem appropriate. All witnesses shall be subject to cross-examination at the conclusion of their testimony on the issues identified by the parties at the prehearing conference held on February 4, 2015.
