2 **CHAIRMAN GRAHAM:** Okay. Well, I know that we
3 have several guests here today. I was told that we
4 have Senator Grimsley here. Senator, welcome. Thank
5 you very much for coming. She is the senator that
6 controls, I guess, the Energy Committee for the Senate.
7 So you are always more than welcome.

8 (Laughter.)

9 And also we have Representative Mayfield.
10 Representative, thank you very much for coming.
11 Now, I was told that you had a few words that you
12 wanted to say; if you want to come up to one of the
13 mikes.

14 **REPRESENTATIVE MAYFIELD:** Does it matter
15 which mike I sit at?

16 **CHAIRMAN GRAHAM:** No. Just push the button.

17 **REPRESENTATIVE MAYFIELD:** Thank you. And I
18 really do appreciate you, Chairman Graham, to give me
19 an opportunity to speak.

20 You know, we have some issues that are
21 going to be coming before you this morning that
22 really should be of no surprise to the
23 Commissioners. And we've had an issue in our Indian
24 River County area for many years, and that's one of
25 the issues that'll be brought up before you. And

1 unlike electric ratepayers that are serviced by
2 investor-owned utilities that you have -- that they
3 have a voice in with you, I have 61 percent of my
4 constituents that are ratepayers to the City of Vero
5 Beach municipality that have no voice. And they
6 have no voice because they do not live within the
7 incorporated area, and the municipalities are exempt
8 from the Public Service Commission. So what you
9 have coming before you are some of those issues.

10 And this is a critical issue for my
11 community, and I just ask that you would please give
12 both sides time to indicate their argument and that
13 you will really take this matter seriously and give
14 some relief to the people that's in our county. So
15 thank you very much.

16 **CHAIRMAN GRAHAM:** Thank you very much, and
17 thank you for coming out.

18 **REPRESENTATIVE MAYFIELD:** Thank you.

19 **CHAIRMAN GRAHAM:** And I was told we also have
20 some county commissioners and city council members. If
21 I can just get you to stand so we can recognize you. I
22 do thank you all very much for coming down and for
23 representing your constituencies.

24 Okay. We will call this meeting to order.
25 This is our Agenda Conference. It is Tuesday,

1 February the 3rd, roughly 9:30 a.m. We have some --
2 let's just get started as normal.
