Pursuant to Section 366.093 of the Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Florida Power & Light requests to confidential classification of highlighted information provided in FPL's response to the Office Of Public Counsel's 1st Set of Interrogatories, (No. 6), as originally filed (Document No. 00821-15), and as Corrected (Document No. 00953-15).

FPL's response to the Office Of Public Counsel's 1st Set of Interrogatories was filed on February 6, 2015. On February 13, 2015, FPL filed the Corrected version of those responses (Document No. 00953-15), stating that the instant document replaces the original filing.

Staff has reviewed FPL's requests for confidential classification of highlighted information in the original and corrected responses to the Office Of Public Counsel's 1st Set of Interrogatories (No. 6). In staff's opinion, the requests meet the criteria for confidentiality contained in Section 366.093, Florida Statutes. Therefore, staff recommends that the request for confidential classification of certain information included in Document Nos. 00821-15 and 00953-15 be approved.
