5 Suzanne Brownless, a staff attorney here.

6 Item Number 2 before the Commission today
7 is here for acknowledgment of Brenda Rodriguez's
8 voluntary withdrawal of her request for an
9 evidentiary hearing regarding allegations of meter
10 tampering and improper billing by Duke Energy
11 Florida, Inc.

12 By operation of law, the withdrawal
13 removes jurisdiction over this matter from the
14 Commission and renders PAA Order PSC-14-0303, issued
15 on June 12th, 2014, null and void.

16 We recommend acknowledgment of
17 Ms. withdrawal -- Ms. Rodriguez's withdrawal and
18 closure of the docket. I'll be glad to answer any
19 questions you may have.

20 **CHAIRMAN GRAHAM:** Thank you, staff. I
21 want to personally thank Commissioner Brisé for
22 handling this for the Commission. This was
23 something that's dragged on for quite a bit, and he
24 was able to negotiate this pretty well, so I do
