Dear Ms. Stauffer:

The following are the responses of Pluris Wedgefield, Inc., ("Utility") to the Staff's Deficiency Letter dated March 3, 2015:

1. In accordance with Rule 25-30.036(3)(1), Florida Administrative Code (F.A.C.), please provide documentation stating with particularity the amount and type of cash and property that the prospective customer will provide as contributions in aid of construction (CIAC).

Response: The Orange County School Board ("OCSB") will pay \$18,557.37 in Service Availability Charges pursuant to the Utility's Tariff. In addition, OCSB will reimburse the Utility for pumping and storage facilities at the water treatment plant in the estimated amount of \$662,000 and a bar screen at the wastewater treatment plant in the estimated amount of \$150,000. In addition, the OCSB will construct the water lines and wastewater force main to connect the OCSB property to the Utility's existing water and wastewater lines at an estimated cost of \$933,650 for the water line and \$256,245 for the wastewater line.

2. In accordance with Rule 25-30.030(6), F.A.C., please provide proof that all current customers have been provided notice of the pending application, including an Affidavit of Mailing.

Response: Rule 25-30.036(6), F.A.C., does not require noticing of existing customers.

3. Rule 25-30.036(j), F.A.C., requires that the Utility submit a statement describing the capacity of the existing lines, of the existing treatment facilities, and the capacity required for the proposed extension. The Utility provided a statement that Pluris has sufficient capacity. The actual capacity of the existing lines and treatment facilities was not provided. Please provide the capacity of the existing lines and treatment facilities and of the capacity requirements for the proposed extension.

Response: The water main connecting to the school property has a capacity of 700 gpm at 52 psi. The wastewater main will be constructed by the OCSB was will not connect to any existing wastewater mains. The WWTP has a capacity of 330,000 gpd and currently averages approximately 250,000 gpd. The WTP has a capacity of 1.0 mgd, and averages approximately 300,000 gpd.

4. Rule 25-30.030(2)(b), F.A.C., requires that the description of territory proposed to be served shall not rely on references to recorded plats or lots. The Utility provided a territory description that relies on a recorded plat for the point of beginning. Please make the appropriate corrections and submit a revised description of territory.

<u>Response:</u> Attached is a Sketch and Legal Description that does not rely on plats or lots. Upon request, the Utility can provide the Staff with the legal description in Word format.

5. Rule 25-30.036(f), F.A.C., requires that the system map should show the territory proposed to be served of sufficient scale and detail to enable correlation with the description of the territory. The Utility provided a territory map that is not of sufficient scale and detail. Please provide a territory map or maps of sufficient scale such as 1" = 100' with the proposed territory clearly indicated.

Response: The Utility has provided a larger scale map directly to the engineering staff.

 Rule 25-30.036(k), F.A.C., requires that the Utility submit numbers and dates of permits for the revised system. The dates for the permits were not provided. Please submit the numbers and dates of any permits for the revised system.

Response: PWS ID #3480149 is an identification number and thus has no expiration date, and DEP WWTP Operating Permit #FLA010900 expires January 27, 2020. The Utility's Water Use Permit #2-095-3302-6 expires July 9, 2033.
