Dear Mr. Smallridge:

We have received East Marion Utility, LLC's (East Marion or Utility) application submitted on March 17, 2015. Rule 25-30.030(2)(b), Florida Administrative Code (F.A.C.), requires that the territory description included in the notice shall not rely on references to government lots, local streets, recorded plats or lots, tracts, or other recorded instruments. Staff's review of the provided territory description has revealed that the third area described (beginning with "Also: Lots 107") and the fifth area described (containing "north of Fort Gates Road") do not comply with this requirement. Please provide an amended territory description that complies with the requirements set forth in the Rule.

Additionally, payment of the filing fee of \$1,500 was not included in the application. We will be unable to proceed with the transfer process until the filing fee has been paid.


