On March 31, 2015, the Florida Division of Chesapeake Utilities Corporation (Chesapeake) filed a request for confidential classification for Document No. 01743-15. The information in the document for which Chesapeake seeks confidential treatment relates to costs to pool customers, customer-specific account and system requirements information, and cost allocation information that could be used to extrapolate the contractual terms along with related earnings information that is not yet final or publicly disclosed. Staff has reviewed the document and concurs with Chesapeake that the nature of the information meets the requirements set forth in Section 366.093(3)(d) and (e), Florida Statutes, whereby disclosure of the information would be harmful to the competitive business operations of Chesapeake.
