**COMMUNICATIONS AUTHORITY, INC.'s OPPOSITION TO AT&T'S MOTION
TO COMPEL AND FOR EXPEDITED CONSIDERATION**

On March 30, 2015, AT&T filed its Motion to Compel and for Expedited Consideration ("Motion"). Later that day, Communications Authority filed its First Supplemental Response to AT&T's Second Set of Requests for Admission, Interrogatories and Requests for Production of Documents. Subsequent to the filing, counsel for AT&T sent an email claiming that the filing omitted AT&T's requested information. Counsel for Communications Authority responded pointing out where in the filing the allegedly omitted information could be found. AT&T has not responded to that email, and as such, it appears AT&T's concerns have been addressed. AT&T has not, however withdrawn its pending Motion. Given Communications Authority's First Supplemental Response and cooperation with AT&T's demands, AT&T's pending Motion is moot. The Commission should dismiss the Motion in its entirety.
