MR. GRAVES: Good morning, Commissioners. Robert Graves from staff.

Item 3 is staff's recommendation addressing Gulf Power Company's petition requesting recovery of costs incurred under an energy purchase agreement with Morgan Stanley.

Morgan Stanley's energy commitment is shaped to match the output of the Kingfisher Wind generation facility, which is to be constructed in Oklahoma.

Under the agreement, Gulf will pay a fixed rate for energy received during the 20-year term of the agreement. Gulf will also receive all renewable energy credits associated with the output of the Kingfisher facility.

Staff believes Gulf has reasonably demonstrated that the agreement will encourage the development of renewable generation and provide a savings of \$11 million to \$48 million to its customers. Staff recommends that the Commission approve Gulf's petition.
