5           **MS. BUYS:** Item No. 6 and Item No. 7 is the  
6 joint application of GCP REIT II and Sun Communities  
7 Operating, Operating Limited Partnership for  
8 transferring majority organizational control of GCP  
9 Fairfield Village and Sunlake Estates Utilities.

10           Fairfield Village is a water and wastewater  
11 company serving about 260 customers in Marion County.  
12 Sunlake Estates Utilities is a water and wastewater  
13 company serving about 460 customers in Lake County. The  
14 majority of organizational control for both utilities  
15 will be transferred to Sun Communities, LLP. Staff is  
16 recommending approval of the transfers.

17           **CHAIRMAN GRAHAM:** Commissioners, any further  
18 discussion, questions of staff?

19           **COMMISSIONER BROWN:** Mr. Chairman, I -- Mr.  
20 Chairman, I move Items 6 and 7 with staff  
21 recommendation.
