6 Peninsula Pipeline Company for approval of a natural gas  
7 Transportation Service Agreement with Central Florida  
8 Gas. The initial term of the proposed agreement is 20  
9 years, with an option to extend for additional ten-year  
10 increments. Staff believes the proposed agreement is  
11 reasonable, meets the requirements of Section 368.105,  
12 *Florida Statutes*, and benefits CFG's customers. Staff
