Hi Matthew,

I appreciate your providing clarification regarding the document filing. Unfortunately, the document itself doesn't indicate that it's a corrected, revised, updated, amended, or otherwise changed version. Anyone looking at the filing on-line will see the same cover page, first page of the testimony, and certificate of service and not see that anything was changed, thus, it would appear to be a duplicate. Please note that the "title" submitted on-line is not considered a part of the record. It is similar to a fax transmittal sheet.

You will need to discuss this filing with the attorney assigned to the docket, regarding any appropriate language that should be used; whether a cover letter would suffice; the certificate of service should be updated; or if you will need to request to have the testimony received later than the 6/22/15 due date, as the Clerk's Office is not authorized to grant extensions, or to provide legal advice regarding the content of filings.
