5 Item 7 is Tampa Electric's petition for
6 approval of its revised underground residential
7 distribution tariffs. The tariffs provide standard
8 charges for underground service in new subdivisions,
9 residential subdivisions, and represent the additional
10 costs that the utility incurs to provide underground
11 service in place of the standard overhead service.

12 Staff has reviewed Tampa Electric's proposed
13 distribution tariffs and the associated charges, as well
14 as the company's response to staff's data request. We
15 believe the proposed charges are reasonable and
16 recommend Commission approval.
