3           **MS. OLLILA:** Item 8 is Gulf Power's request to  
4 modify its underground residential distribution tariffs.  
5 Again, the tariff provides standard charges for  
6 underground service in new residential subdivisions, and  
7 represents the additional costs the utility incurs to  
8 provide underground service in lieu of the standard  
9 overhead service.

10           Staff has reviewed Gulf Power's proposed  
11 tariffs and the associated charges, as well as Gulf's  
12 responses to staff's data requests. We believe the  
13 proposed charges are reasonable, and we recommend  
14 approval.

15           **CHAIRMAN GRAHAM:** Commissioners, questions of  
16 staff on Item No. 8? Seeing none, can I get a rec -- a  
17 motion.

18           **COMMISSIONER PATRONIS:** Move staff.

19           **CHAIRMAN GRAHAM:** It's been moved and
