CHAIRMAN GRAHAM: Now let's move on to Item No. 10.

MR. GARL: Thank you, Mr. Chairman. Commissioners, I'm Steve Garl with Commission staff.

Item 10 is a joint petition from Peoples Gas System and Sebring Gas System requesting approval of a territorial agreement between the two companies. Both companies serve customers in Hardee County. The area addressed by the agreement is also in Hardee County, specifically within the jurisdiction of the City of Wauchula.

The agreement was prompted by the City of Wauchula granting a franchise to Sebring for natural gas service. Since the City has not had gas service previously, there are no customers or facility transfers involved with the territorial agreement.

Furthermore, the agreement precludes any uneconomic duplication of facilities. In addition, the territorial agreement does not cause a detriment to the public interest. Staff recommends approval.
