approval of its revised net metering tariff and

agreement adopting terms of the standard interconnection

systems.

Staff has an oral modification for Issue 1 on page 3. Under staff's analysis, staff would strike the terms "rate increase" and replace with "proposed tariff revision." The sentence would read, "The suspension of the proposed tariff revision is authorized by Section 366.063, Florida Statutes." This modification accurately reflects the purpose of the petition.

Staff recommends the revised net metering tariff and agreement adopting terms of the standard interconnection agreement for Tier 1, 2, or 3 renewable generator systems be suspended pending a final decision in this docket.
