2 **CHAIRMAN GRAHAM:** Okay. We'll come back to
3 Item No. 11. Let's get down to Item No. 12.

4 **MS. AMES:** Good morning, Commissioners. Item
5 12 is staff's recommendation on TECO's petition for
6 approval of its revised net metering tariff and
7 agreement adopting terms of the standard interconnection
8 agreement for Tier 1, 2, or 3 renewable generator
9 systems.

10 Staff has an oral modification for Issue 1 on
11 page 3. Under staff's analysis, staff would strike the
12 terms "rate increase" and replace with "proposed tariff
13 revision." The sentence would read, "The suspension of
14 the proposed tariff revision is authorized by Section
15 366.063, *Florida Statutes*." This modification
16 accurately reflects the purpose of the petition.

17 Staff recommends the revised net metering
18 tariff and agreement adopting terms of the standard
19 interconnection agreement for Tier 1, 2, or 3 renewable
20 generator systems be suspended pending a final decision
21 in this docket.

22 **CHAIRMAN GRAHAM:** Commissioners, questions of
23 staff? Seeing none, I'll entertain a motion.

24 **COMMISSIONER EDGAR:** Move staff.

25 **COMMISSIONER BROWN:** Second.

1 **CHAIRMAN GRAHAM:** It's been moved and
