Dear Ms. Stauffer:

Cedar Bay Generating Company, Limited Partnership ("Cedar Bay") has identified a scrivener's error in Cedar Bay's REVISED Tenth Request for Confidential Classification ("RFCC"), PSC Document No. 04450-15. The error, which occurred only in the RFCC itself, was a reference to Deposition Exhibits "38 and 39," which were exhibits to the depositions of Tracy Patterson, Charles Richard Neff, Stephen Mark Rudolph, and Clifford Evans. As there were only 38 exhibits to the depositions, this was a typographical error, and the reference should have been to Deposition Exhibits "37 and 38," not to Exhibits "38 and 39." Please note that the references in Exhibits A, B, C, and D to Cedar Bay's REVISED Tenth RFCC, including the deposition exhibits themselves in Exhibits A (highlighted confidential) and B (redacted public versions), the justification table that is Exhibit C, and the Affidavit of Jacob A. Pollack (Exhibit D to the RFCC), all correctly refer to Exhibits 37 and 38.

In view of the fact that this was a typographical error, and that the substantive components of the filing, i.e., the Exhibits themselves, the justification table, and Mr. Pollack's affidavit, all identify the Exhibits correctly, we believe that this letter should suffice to notify all parties of this scrivener's error. If you or the Commission Legal staff believe that we should file anything in addition to this letter, please advise us and we will do so promptly.
