We will be glad to add you to the mailing lists for individual dockets, however, you will need to specify the docket numbers for the dockets you are interested in being added to. Please note that the Commission is unable to automatically add persons to future new dockets. If you wish to be included on future dockets, you will need to provide requests for those specific dockets as well.

Interested persons receive all notices for hearing, prehearing, proposed agency action orders, final orders, and notices of Commission conferences via e-mail. If you are interested in receiving documents other than those mentioned above, for example, procedural orders, please contact staff counsel for instructions on becoming a party of record in specific dockets. The phone number for our General Counsel's Office is 850-413-6199.

As for the petition for determination of need, I do not see that there is a current petition for FPL in Hendry County. The only determination of need docket that I see is a closed docket from 2003, Docket No. 030084-EI.
