7 Item 19 is the petition filed by Peoples Gas
8 for approval of an amendment to the transportation
9 service agreement with Peninsula Pipeline Company.
10 Peoples' 1.6-mile interconnect with Southern Natural Gas
11 Company's Cypress Lateral will enable Peoples to provide
12 additional gas transportation capacity to Peninsula in
13 Nassau County.

14 The amendment establishes rates that cover the
15 cost of service and, therefore, benefits Peoples'
16 general body of ratepayers. Staff recommends approval.
