14 lease premises that have renewable generation systems  
15 installed by the property owner. This new agreement  
16 contains a more limited range of applications applicable  
17 to renters. TECO is also making changes to its existing  
18 tariff to incorporate references to the new agreement.  
19 Staff is available to answer any questions you might  
20 have.
