Here is the link we promised for viewing documents for the public water system. Let me know if you have any questions.

Reports and other documents pertaining to all public water systems may be viewed in Oculus, the online document management system. The instructions are as follows:

The link to OCULUS:

<http://depedms.dep.state.fl.us/Oculus/servlet/login>

When the page opens, choose *PUBLIC OCULUS LOGIN*

This will open a search page with Catalog and Profile selections on the left hand side of the page.

Choose the Catalog *Potable Water Systems*. When you do this, you will see the list of Profile options change. To choose all the Profiles to search at one time, Click *Administrative*, hold the shift key, and choose *Sampling*. This should select all Profiles.

On the right side of the page will be more detailed search options. Enter **6604824** for the Facility-Site ID. If the Facility – Site ID is not known, you may perform a property lookup by clicking the box to the right of the Facility-Site ID box. Enter the PWS ID# in the Facility-Site ID field and press the Enter key. The County, District, Name, and Facility Type will auto-fill. Click *Search* to execute the search.

Pages of documents will appear, ten at a time, that are categorized by document type and in order of document date, oldest to newest. You may change how many results per page you view if you prefer to see more at one time.
