The original and one (1) copy of this letter is submitted on behalf of ACN Communication Services, Inc. ("ACN" or "Company") as notification to the Commission of a change in Company name to ACN Communication Services, LLC. ACN received a Certificate to Provide Alternative Local Exchange Telecommunication services, Certificate No. 8287, within the state of Florida on February 24, 2003.

On July 24, 2015, ACN Communication Services, Inc., a Michigan corporation, underwent a statutory conversion to become ACN Communication Services, LLC, a Michigan limited liability company. The conversion of the Company to a limited liability company was merely a change in its corporate form accomplished through the filing of a Certificate of Conversion in Michigan and did not entail any merger or other transactions interrupting the existence of the Company.

The change in corporate form will have no customer impact, as the name reflected in all customer communications (bills, notices, customer service, etc.) will remain "ACN Communication Services." Therefore, customer notice was not required. However, a bill message notice is being provided to customers stating: "ACN Communication Services, Inc.' has converted to a limited liability company and its name is now 'ACN Communication Services, LLC'. This change will be processed by the appropriate authority(ies) in your state, but it will not affect your service or rates, including any of your rights or obligations."

Included with this filing are a Change of Information on Regulated Utility form, a copy of the Michigan Certificate of Conversion and a copy of the registration as a limited liability company with the Florida Secretary of State.

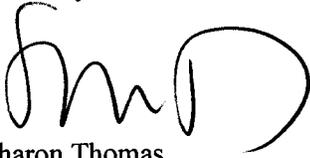

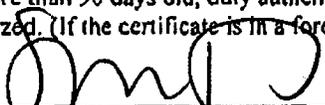

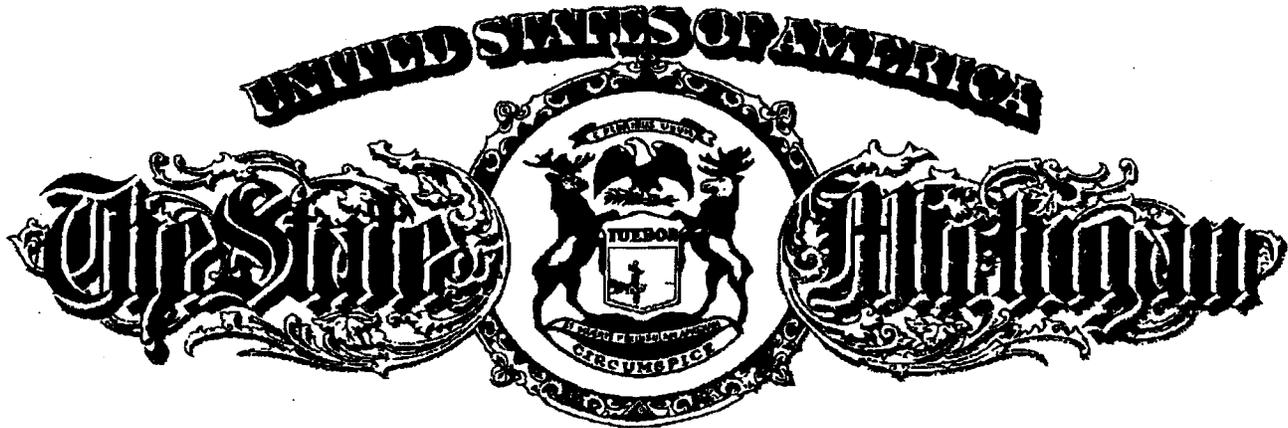
