Item 5 is an initiation of a show cause proceeding against Sun-Tel USA, Inc., for failing to keep a current Florida corporate registration, failing to file updated contact information with the Commission Clerk, failing to submit quarterly Lifeline data, and for failing to provide the Commission access to company records.

Staff is recommending the Commission order Sun-Tel to show cause in writing within 21 days of the date of the order why it should not be penalized \$2,000 or its certificate and ETC designation be canceled for its apparent violations. Sun-Tel should be ordered to come into compliance with all statute and rules it is currently in violation of in order to maintain both its CLEC certificate and ETC designation. If Sun-Tel fails to respond or comply with the show cause order and/or remit the penalty, the facts should be deemed admitted and the company's certificate and ETC designation should be canceled. Staff is

available to answer any questions. CHAIRMAN GRAHAM: Commissioners, any questions of staff on Item No. 5? Seeing none, I'll entertain a motion. **COMMISSIONER BROWN:** Move staff.
