5 Item 10 is a joint petition by Tampa Electric,
6 Duke Energy, and Mosaic Fertilizer for approval of an
7 intermittent electric standby power agreement. Mosaic
8 plans to build a transmission line on its property to
9 allow its South Pierce Cogeneration Facility to serve
10 the load of a Mosaic Fertilizer production plant called
11 the Pasture Plant. The proposed agreement would allow
12 Tampa Electric to provide standby power to Mosaic when
13 generation from the cogeneration facility is not
14 sufficient to serve the Pasture Plant load.

15 Staff recommends approval of the proposed
16 agreement as it is consistent with the Commission's
17 policy to encourage agreements and promotes renewable
18 energy.
