Enclosed I have copies of bills for Sept. and Oct. The base rate has changed from \$29.34 to \$48.19. The rate/ 1000 Gal. has changed from \$6.59 to \$12.63. My bill from Sept. to Oct. has gone from \$35.93 to \$99.45. I called Utilities Inc. and asked what was going on. I told him I thought that an interim base rate was set at \$34.60 and the interim rate/1000/gal. \$7.77. His response was "you think you know more than me" and then hung up on me. This was the information we received from the company. The local input meeting is Oct. 24th and I will be out of state. I will give this information to an attendee but want the commission to understand with what we are dealing. I have an auto-pay account and have no idea what to do.

My understanding is that our sewage is now going to Englewood Water District (EWD) as of Oct. 1. Sandalhaven is now only a pipeline company and no longer will need employees to run a treatment plant. These rates are so out of line with any of our other utilities that are only two blocks away. We are already hocked up to EWD. My understanding is, this was forced by the EPA. By giving them outrageous increases there is no incentive for them to sell the remaining infrastructure to someone who is capable of operating it at a normal rate. Either EWD or Charlotte County Utilities are already there. We will be paying outrageous rates forever. Once given, these rates will never go down to a reasonable level. Due to the monopoly utilities have, your commission is our only recourse. I hope you can do the job you were appointed to do.
