Mr. Szabo,

In reviewing the billing documents forwarded to Staff by Mr. Bentley, it appears that Sunrise may be collecting reconnection fee amounts that have not been approved by the Commission. For example:

- (1) The "Final Notice" sent to Mr. Bentley on August 26, 2015, states that a \$25.00 reconnect fee will be charged if service is disconnected.
- (2) The "Cutoff Notice" sent to Mr. Bentley on September 25, 2015, states that a \$30.00 reconnect fee will be charged if service is disconnected.

Under its current approved tariff, Sunrise is only authorized to collect a \$15.00 reconnection fee. I have attached a copy of Sunrise's tariff sheet on file with the Commission containing the miscellaneous service charges Sunrise is authorized to collect.

Please note that a utility may only charge and collect rates and fees that have been approved by the Commission. Charging and/or collecting rates and fees in excess of what has been approved by the Commission is a violation of Florida law and Commission rules.

Please ensure that Sunrise is charging and collecting fees that have been approved by the Commission. If you have any questions on the amounts of the rates, fees or charges that Sunrise is authorized to collect, you can request a full copy of the Utility's tariff that is on file with the Commission.

NORMAL RECONNECTION - This charge may be levied for transfer of service to a new Customer account at a previously served location or reconnection of service subsequent to a Customer requested disconnection.

VIOLATION RECONNECTION - This charge may be levied prior to reconnection of an existing Customer after disconnection of service for cause according to Rule 25-30,320(2), Florida Administrative Code, including a delinquency in bill payment.

PREMISES VISIT CHARGE (IN LIEU OF DISCONNECTION) - This charge may be levied when a service representative visits a premises for the purpose of discontinuing service for nonpayment of a due and collectible bill and does not discontinue service because the Customer pays the service representative or otherwise makes satisfactory arrangements to pay the bill.
