A. Known Witnesses

Florida City Gas has appropriately calculated its true-up amounts and purchased gas adjustment factor as shown in the Company's positions on Issues 1-6.

<u>Issue 1:</u> What are the final purchased gas adjustment true-up amounts for the

period January 2014 through December 2014?

Florida City Gas: An over-recovery of \$1,486,853.

<u>Issue 2:</u> What are the actual/estimated purchased gas adjustment true-up

amounts for the period January 2015 through December 2015?

Florida City Gas: An under-recovery of \$930,395.

Issue 3: What are the total purchased gas adjustment true-up amounts to be

collected during the period January 2016 through December 2016?

Florida City Gas: An over-recovery of \$556,458, for a true-up refund factor of 1.275

cents per therm.

Issue 4: What are the levelized purchased gas cost recovery (cap) factors for

the period January 2016 through December 2016?

Florida City Gas: Based on the winter months of October through March the

appropriate (cap) factors are 72.517 cents per therm before the regulatory assessment fees are added and 72.882 cents per therm

with regulatory assessment fees included.

<u>Issue 5:</u> What should be the effective date of the new purchased gas

adjustment charge for billing purposes?

Florida City Gas: The factors should be effective for all meter readings on or after

January 1, 2016 and should apply for bills rendered for meter

readings taken between January 1, 2016 and December 31, 2016.

Issue 6: Should the Commission approve revised tariffs reflecting the new

purchased gas adjustment charges determined to be appropriate in

this proceeding?

Florida City Gas: Agree with Commission Staff.

G. Stipulated Issues

Florida City Gas is not a party to any stipulations at this time, although it believes that it should be possible to reach a stipulation on each of the above issues as they relate to Florida City Gas.
