By this letter, the Commission staff requests that Sunrise Utilities, L.L.C (Sunrise or Utility) provide responses to the following data requests.

Utility Billing:

Sunrise still has not responded to Staff's previous request for billing record samples. As Staff has explained to the Utility, Staff must review several consecutive months of the Utility's billing records in order to verify that Sunrise is correctly assessing late fees and miscellaneous service charges. Therefore, please provide the following documents by **Monday**, **October 19**, **2015**:

- 1. In correspondence with Staff dated August 10, 2015, Sunrise provided a Detail Report (dated June 9, 2015) that included billing information on all of Sunrise's customers. Please provide a copy of the Detail Reports for May 2015 and July 2015.
- 2. In correspondence with Staff dated August 10, 2015, Sunrise provided a Receipts History (dated July 14, 2015) that showed the payments that Sunrise received from customers between June 1, 2015 and July 13, 2015. Please provide a copy of the Receipts History for April, May, the rest of July, August, and September 2015.

- b. A copy of each customer's monthly Utility Bill issued in April, May, June, July, and August 2015.
- c. A copy of any Final Notices that were issued to each of these customers in <u>April</u>, <u>May</u>, <u>June</u>, <u>July</u>, and <u>August 2015</u>.
- d. A copy of any Cutoff Notices that were issued to each of these customers in <u>April</u>, <u>May</u>, <u>June</u>, <u>July</u>, and <u>August 2015</u>.
