Re: Voluntary Surrender of One Source Networks CLEC LLC CLEC Certification,
No. 8735; Authority No. T-08-0528

Dear Ms. Stauffer:

One Source Networks CLEC LLC (“One Source” or the “Company”), by its attorneys, voluntarily surrenders its certificate to operate as a competitive local exchange company (“CLEC Certificate”) granted by the Florida Public Service Commission (“Commission”).

One Source was granted a CLEC Certificate on October 15, 2008 in Docket No. 080519-TX.¹ At the time One Source obtained its certification it anticipated it would be providing services subject to Commission regulation. One Source does not have any subscribers for regulated services in Florida nor does the Company intend to provide any intrastate telecommunications services in Florida. One Source provides, and intends to continue providing, only interstate services on a private carriage basis. Accordingly, One Source seeks to surrender its CLEC Certificate.


The surrender of One Source’s CLEC Certificate will not reduce the number of telecommunications providers in Florida as One Source intends to continue providing its unregulated services to its subscribers. One Source’s CLEC Certificate surrender also will not have any negative impacts on the market for regulated telecommunications services as the Company does not offer such service, nor does the Company intend to offer such service in the future. Accordingly, One Source requests immediate cancellation of its CLEC Certificate.


