This information should be considered proprietary confidential information in that is (i) intended to be and is treated as private, confidential information, (ii) because disclosure of the information would cause irreparable harm to Black Bear Waterworks Inc.'s business operation and its customers, and (iii) the information has not been voluntarily disclosed to the public.

Wherefore, Black Bear Waterworks respectfully request that the requested information be granted confidential classification and treated accordingly. The above utilities request that the information be classified as "proprietary confidential business information" within the meaning of Section 366.093(3), F.S. that, the information remain confidential for a period of at least 18 months as provided in Section 366.093(4), F.S., and that the information be returned as soon as it is no longer necessary for the Commission to conduct its business.
