On October 26, 2015, Peoples Gas System (Peoples) filed a request for confidential classification for Document No. 06835-15. This document consists of the company's responses to Commission staff's First Data Request in the subject docket. The information in the document for which Peoples seeks confidential treatment relates to information from which the rates at which service will be provided to Peoples by SeaCoast Gas Transmission, L.L.C. could be arithmetically determined, and information regarding details of Swing Service Agreements between Peoples and two of its customers. Staff has reviewed the document and concurs with Peoples that the nature of the information meets the requirements set forth in Section 366.093(3)(d) and (e), Florida Statutes, whereby disclosure of the information would harm the competitive business operations of Peoples.

Therefore, staff recommends that the request by Peoples for confidential classification of Document No. 06835-15 be approved.
