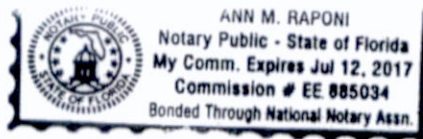

NOTICE OF APPLICATION FOR AN EXTENSION OF SERVICE AREA

NOTICE IS HEREBY GIVEN on this 11th day of November, 2015, pursuant to Section 367.045, Florida Statutes, and Section 25-30.030, Florida Administrative Code, of the of the Application of Sanlando Utilities Corporation, to amend Water Certificate No. 247-W, to add territory in Seminole County, Florida. The Applicant proposes to extend its existing certificated water service area to include the following land in Seminole County, Florida:

MYRTLE LAKE HILLS SUBDIVISION

A tract of land lying in of Section 25, Township 20 South, Range 29 East, Seminole County, Florida, being more particularly described as follows:

Commencing at the intersection of the West Right-of-Way line of Interstate No. 4 with the North line of said Section 25, Township 20 South, Range 29 East; thence East 2550 feet, thence South 500 feet to the POINT of BEGINNING; thence South 45° West 600 feet, thence West 160 feet, thence South 150 feet, thence East 140 feet, thence South 110 feet, thence West 150 feet, thence South 75 feet, thence West 125 feet, thence South 755 feet, thence East 275 feet, thence South 160 feet, thence West 350 feet, thence South 150 feet, thence East 1800 feet to the East line of Section 25, Township 20 South, Range 29 East, thence North 1010 feet, thence North 22° West 878.2 feet, thence West 676.75 feet to the POINT of BEGINNING.
