Dear Ms. Cowdery:

I have reviewed the above-referenced rules and offer the following comments for your consideration and response:

25-30.033(1):	<u>Incorporated Material—PSC 1001 (12/15)</u> Part I, D: The corresponding rule language found in rule 25-30.033(1)(e), Florida Administrative Code, requests a listing of each "entity or person" that owns or will own more than 5% of the utility. Please note that the question on the sample application requests "each entity" only. Please review to determine whether revision is necessary for consistency.
25-30.033(1)(p)2.:	The reference to "subparagraph (p)6." should be to "subparagraph (1)(p)6."
25-30.033(1)(q):	<u>Incorporated Material—PSC 1010 and PSC1011 (12/15)</u> For both incorporated forms, only rule 25-30.033 should be listed in the footer as incorporating these forms by reference. The other listed rules refer to, but do not separately incorporate, these forms.
25-30.034(1):	<u>Incorporated Material—PSC 1002 (12/15)</u> Part I, D: Please see the comment above for rule 25-30.033(1) as it relates to Part I, D of this application.
25-30.035(1):	The reference to "paragraphs (2) through (16)" should be to "subsections (2) through (16)."
