Dear Member:

Clay Electric Cooperative, Inc. (CEC) and Duke Energy (Duke) have entered into a new territorial agreement that designates electric service boundary lines within Alachua, Columbia, Levy, Marion and Volusia Counties for both utilities. The new agreement comes after years of negotiating previously expired agreements.

The new agreement will now be sent to the Florida Public Service Commission (FPSC). If approved by the FPSC, your electric service is among the approximately 361 CEC accounts in Alachua, Columbia, Levy, Marion and Volusia Counties that will be transferred to Duke within three years of approval by the PSC.

This territorial agreement will enable each utility to serve its customers more reliably and economically. The PSC has previously recognized the benefits of territorial agreements and encourages utilities to enter into this type of agreement.

To provide you a rate comparison, from the most recent published rate available on the FPSC website, the commercial rate of Clay Electric for 1,500 Kilowatt-Hours (kWh) was \$187.00. For the same month, the commercial rate of Duke Energy for 1,500 kWh was \$186.00. These rates of both utilities are subject to periodic change and may be raised or lowered in the future.
