No. 6 addresses Little Gasparilla's request to extend the time to complete the Phase II pro forma plant items for the construction of a new building and meter replacement. Sorry.

The utility notified staff that it would be unable to meet its deadline to complete the Phase II pro forma items on November 13th, 2015. The utility was granted 12 months to complete the pro forma items, which should have been completed on December 3rd, 2015.

On December 8th, the utility requested it be granted an extension of six months to complete the Phase II pro forma plant items.

Staff recommends that the extension be granted. This extension does not place any burden on the customers. Phase II rates cannot be determined or implemented until all costs for the pro forma -- pro forma are evaluated. The utility is not present and there has been no customer contact. Staff is prepared to answer any questions that you may have.
