By Order No. PSC-15-0588-PAA-WU, in Docket No. 140177-WU, issued December 29, 2015, the Florida Public Service Commission (Commission) approved an increase in water rates, added a Non-Sufficient Funds (NSF) charge, and amended the initial customer deposit for Holiday Gardens Utilities, LLC (utility). Miscellaneous Service Charges

NSF Charge Pursuant to Statute

The rates shall be effective for service rendered as of the Commission's stamped approval date on the tariff sheets provided the customers have received notice. If the effective date of the new rates falls within a regular billing cycle, the initial bills at the new rate may be prorated. The old charges shall be prorated based on the number of days in the billing cycle before the effective date of the new rates. The new charges shall be prorated based on the number of days in the billing cycle on or after the effective date of the new rates.
