

By Order No. PSC-15-0592-PAA-WU, in Docket No. 140175-WU, issued December 30, 2015, the Florida Public Service Commission (Commission) approved an increase in water rates, added a Non-Sufficient Funds (NSF) charge, and amended the initial customer deposit for Crestridge Utilities, LLC (utility).
