UNOPPOSED MOTION FOR EXTENSION OF TIME**

BellSouth Telecommunications, LLC d/b/a AT&T Florida ("AT&T"), pursuant to Rule 28.106-204, Florida Administrative Code, hereby file this Unopposed Motion for Extension of Time to complete review of the language of the conforming interconnection agreement as determined by the Florida Public Service Commission ("Commission") in Order No. PSC-15-0593-FOF-TP issued December 30, 2015. In support, AT&T states:

1. Order No. PSC-15-0593-FOF-TP requires that a conformed interconnection agreement reflecting the decision of the Commission in the instant proceeding be filed within thirty (30) days from the date of issuance.

3. The Parties have determined that addition time is required to complete the review of the conformed agreement.

Accordingly, the parties request that the Commission extend the time for filing a conformed interconnection agreement until February 19, 2016.

4. No party will be prejudiced by the requested extension.

5. Pursuant to Rule 28.106-204, AT&T has consulted with CA and is authorized to state that CA has no objection.

WHEREFORE, for the foregoing reasons, AT&T requests that the time for filing a conforming interconnection agreement be extended to February 19, 2016.


