2 **CHAIRMAN BROWN:** Moving on to Item 4, which
3 has an oral modification.

4 **MR. BATES:** Good morning, Commissioners. I'm
5 Jeff Bates with technical staff.

6 Item No. 4 is Docket No. 000121B-TP and is
7 CenturyLink's filing to incorporate changes into its
8 performance measurement plan. Performance measures are
9 designed to ensure incumbent carriers treat competitive
10 carriers fairly.

11 Staff has two oral modifications for Issue 1
12 on page 4 of the recommendation. The first change is
13 in the first paragraph under measurable standards and
14 modifications and corrects a number of measures being
15 eliminated to 16 instead of 15.

16 The second modification is to the final
17 item of the bulleted list, and it should read as two of
18 the measures eliminated, instead of one, relate to the
19 availability of the OSS interface, and the measures
20 being eliminated include both Measures 42 and
21 44 instead of just 42.
