CHAIRMAN BROWN: Moving on to Item 5. Good morning.

MR. VOGEL: Good morning, Commissioners. Matthew Vogel with Commission staff.

Item No. 5 is staff's recommendation which addresses East Marion Utilities, LLC's request for an interim rate increase. East Marion is a Class C utility that currently serves approximately 101 water and 93 wastewater customers in Marion County. East Marion's rate base was last established by the Commission in 2002.

Staff is recommending an interim water increase of \$4,316, or approximately 18 percent. accordance with Section 367.814(4), Florida Statutes, the interim water increase is limited to operation and maintenance expenses and the regulatory assessment fees associated with the interim revenue increase. return on investment is allowed in interim purposes.

The wastewater revenues did exceed the system's operation and maintenance expenses and, therefore, no interim increase is warranted. And at this time staff is prepared to answer any questions. Thank you.
