2 **CHAIRMAN BROWN:** Moving on to Item 8. Thank
3 you.

4 **MS. OLLILA:** Good morning, Commissioners.
5 Sue Ollila for staff.

6 Item 8 is a joint petition from Tampa Electric
7 and Mosaic requesting Commission approval of their joint
8 termination of a 2003 settlement agreement. That
9 agreement was actually between Tampa Electric and
10 Cargill. One year after the agreement was reached in
11 2004, Mosaic was formed by a merger between Cargill's
12 crop nutrition division and IMC Global, a fertilizer
13 company formed in 1909.

14 Mosaic is a large phosphate mining company
15 that produces energy for its own use and sells excess
16 energy to Tampa Electric. The 2003 agreement provided
17 for certain operational arrangements, excuse me, between
18 Mosaic and Tampa Electric that both parties state they
19 no longer desire. The agreement which ended in 2007
20 specifies that either party may terminate the agreement
21 with one year's written notice. Neither party requires
22 the one-year notice. The agreement only impacts Tampa
23 Electric and Mosaic and does not affect Tampa Electric's
24 general body of ratepayers. There were no customer
25 contacts, and staff recommends approval of the joint

1 petition.

2 **CHAIRMAN BROWN:** Thank you. Commissioners,
3 any questions or comments? Okay. I'll entertain a
4 motion.

5 **COMMISSIONER PATRONIS:** Move staff.

6 **COMMISSIONER EDGAR:** Second.

7 **CHAIRMAN BROWN:** All those in favor.

8 (Vote taken.)
