Item 9 is a petition by Florida Power & Light for a --

CHAIRMAN BROWN: Could you move your mike?

MS. GUFFEY: Sorry. Item 9 is a petition by Florida Power & Light for approval of revised tariff. The revised tariff reflects an increase in the base rates and a reduction in fuel factors. Base rates increase as a result of the implementation of the generation base rate adjustment factor resulting from the commercial operation of the new -- FPL's new power plant, the Port Everglades Energy Center. Fuel factors decrease as a result of the fuel savings of the Port Everglades Energy Center. Both the generation base rate adjustment factor and the fuel factors have been already approved by the Commission in the 2015 fuel docket, with the changes in rates to be effective with the in-service date of the Port Everglades Energy Center, which is currently scheduled to be April 1st, 2016. FPL will provide notice to its customers of the revised base rates and fuel factors before April 1st, 2016. Staff did not receive any customer comments on this proposed petition, and staff recommends approval

of FPL's revised tariff.
