

Mason, II. Finally, the fourth stock certificate enclosed is dated July 27, 2009 and evidences the transfer of all 500 shares of stock in Sunny Shores from Jack E. Mason, II to Jack E. Mason, II and Debbie Mason, as tenants by the entireties.
