As a resident of Indian River Shores I wholeheartedly support our petition to redraw service boundaries so that we can be served by Florida Power & Light. The current arrangement which causes the city of Vero Beach("City") to provide our electric service is unfair in that the City prices the electricity to make a profit to subsidize the revenues of the city at my expense. I am not a resident of the City so I can not vote my displeasure so have no voice in the operation or pricing of the utility. In addition to the profit charged by the City, their costs are excessive due to the poor management of

the Florida Municipal Power League of which it is a part.. Finally, my friends in Indian River Shores who are served by Floida Power & Light tell me that they have not had the service interuptions I have experienced. The profit oriented pricing, mismanagement, and reliability are all issues in which I have no voice because I am not a resident of the City, but of Indian River Shores.
