Pursuant to Section 366.093 of the Florida Statutes, and Rule 25-22.006, Florida Administrative Code, Florida Power & Light Company (FPL) requests confidential classification of highlighted information in Weaver and Tidwell LLC's joint interest billing audit plan (prepared for Florida Power & Light Company), dated 4/6/16.
