The purpose of this letter is to advise you of the violations of law for which the above mentioned facility's public water system may be responsible, and to seek your cooperation in resolving the matter. - You may have failed to monitor according to your Disinfection Byproducts Sampling Plan for the compliance period January to March 2016 as required by Chapter 62-550.821 of the Florida Administrative Code and 40 CFR 141, subpart L.

The Department is interested in reviewing any facts you may have that will assist in determining whether any violations have occurred. You may bring anyone with you to the meeting that you feel could help resolve this matter.
