RE: Request for partial release of funds from Escrow Account (Docket No. 110200-WU, Application for increase in water rates in Franklin County by Water Management Services, Inc.)

Pursuant to PAA Order No. PSC-12-0641-PCO-WU, issued December 4, 2012, in the above referenced docket, the Commission granted staff administrative authority to authorize all payments from an established escrow account (hereafter referred to as PAA escrow account) for the Florida Department of Environmental Protection (DEP) loan as they become due.

On June 12, 2015, the monthly transfer of \$28,568.06 from the PAA escrow account to the DEP escrow account was authorized in accordance with the above-referenced Order and Intercreditor Agreement between Ameris Bank, DEP, and Water Management Services, Inc. (WMSI or Utility). The Utility has requested authorization for the partial release of escrow funds in the amount of \$171,408.35 held at Ameris Bank.

Counsel for WMSI has represented that sufficient funds are available in the DEP escrow account to cover the requested withdrawal. Pursuant to the above-referenced Order, staff recommends the Commission's designated agent in such matters authorize the release of \$171,408.35 from the DEP escrow account at Ameris Bank payable to the Florida Department of Environmental Protection in accordance with the amended terms of the DEP loan agreement.

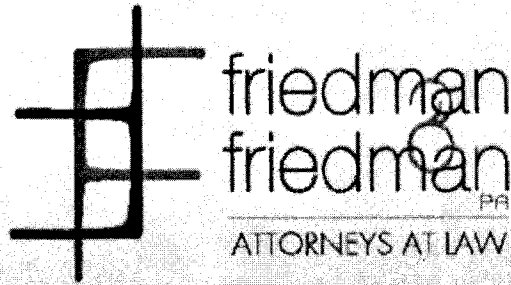
