ORDER TERMINATING RECEIVERSHIP AND CLOSING CASE

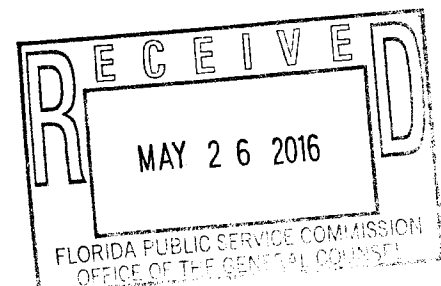
