**FLORIDA POWER & LIGHT COMPANY'S UNOPPOSED MOTION
TO MODIFY TESTIMONY FILING DATE**

Florida Power & Light Company ("FPL") hereby files its Motion to Modify Testimony Filing Date, which would move the date for Staff to file testimony from September 30, 2016 to September 23, 2016. In support of this Motion, FPL states as follows:

1. Order No. PSC-16-0109-PCO-EI, the Order Establishing Procedure for this docket, set certain key procedural dates including the testimony filing dates. It provides for Staff to file testimony on September 30, 2016 and also sets that same date for utilities to file their rebuttal testimony.

2. FPL seldom has occasion to rebut testimony that Staff files in the annual Fuel Clause docket, but there is always a possibility that FPL would need to do so. Under the current schedule in this docket, that would be impossible because the Staff testimony and FPL's rebuttal testimony are due on the same day.

3. FPL has conferred with Staff, which has no objection to moving the filing date for its testimony forward one week, to September 23, 2016. FPL has also confirmed that no party opposes this modification.

WHEREFORE, FPL respectfully requests the Commission to move the filing date for Staff testimony from September 30, 2016 to September 23, 2016.
